Opening: Jean S opened the Zoom meeting at 2:00 pm with the ACA Serenity Prayer. A quorum was established, and members read the 4th Tradition, 4th Concept, and Behavior Goals for ACA Business Meetings. The Mission Statement and Commitment to Service were not read. See attendance above. (IGR's, proxies and officers vote; visitors and committee chairs do not. One vote per person even if filling multiple roles.) 11 voting members were present, meeting our one-less-than-2/3 quorum requirement of 8 . Jean welcomed any new IGRs.

## Minutes:

Motion: (Emily/Laura): Approve minutes of 3/28/20 meeting as written.
(9-0-1), (Approve-Reject-Abstain) Darren arrived after this vote was taken.

7th Tradition: Members in the meeting can use Venmo to make a 7th Tradition contribution to Intergroup if desired.

REPORTS
Chairperson -Jean S Jean reported that James, Chair of the Potluck Speaker Meeting Committee, resigned a few weeks ago. That Chair is available. No volunteers. Jean hosted the Speaker Meeting on April 19 ${ }^{\text {th }}$.
A new Secretary was chosen for the Wednesday 9:30 am meeting.
Vice Chairperson - Laura reported the 2021 ABC/AWC will be held in Boca Raton, Florida and the 2022 ABC/AWC will be held in the San Francisco Bay Area. The 2022 AWC lost its co-chair (Barbara from GEBACA). GEBACA will see if they can replace Barbara as co-chair. Laura is on the 2022 ABC/AWC planning committee and during their April $12^{\text {the }}$ meeting, Laura suggested that the Monterey Bay Intergroup share in the 2022 ABC/AWC planning. The committee agreed if the MBIG was also agreeable. Discussion followed with various questions about the 2022 convention. Most of the convention planning work will be done by an event planner. Laura said she would be interested in being a third co-chair if MBIG wanted to participate. Laura will gather more information on the next call on Sunday, May $10^{\text {th }}$ at $12: 15 \mathrm{pm}$. This list of questions provided to her may be answered:

1. How would we be involved?
2. How many volunteers are required from MBIG?
3. Would our whole Intergroup be involved, or only individuals?
4. What are the financial contributions from MBIG?
5. What are the benefits and costs (financial and personnel)?

Any further questions can be sent to the email account and will be forwarded to Laura. Further discussion was tabled until next month's Intergroup meeting.
The 2020 AWC is going on right now. Good reports have come from attendees of this convention. Registration is free on adultchildren.org.
Secretary - Renée submitted her written report as the Intergroup delegate to the ABC. Renee asked that her written report be posted on the website so the groups can have the ABC information. In summary, the financial picture for ACA has improved over last year and ACA is getting close to becoming self-supporting through its own contributions. Highlights of the ABC are contained in the delegate's report.
Treasurer - Emily reported the reserve balances: Events $\$ 56.41$, Outreach $\$ 65.56$, Travel $\$ 150.00$ and General $\$ 1,702.65$. The domain name (acamontereybay.org) annual invoice is due June $15^{\text {th }}$ and discussion followed on whether the bill can be paid from the ACA checking account electronically or by debit card. Evie, who set up the domain name, Emily and Chris will gather more information and make a recommendation about payment at the next Intergroup meeting.
WSO Representative Report - Tamara was absent but sent her report to Jean via text. Jean read the text which mentioned the new Venmo account for the WSO: @ACAWSO. Contributions can be made to WSO on a link on the adultchildren.org website. WSO also has a PayPal account: treasurer@adultchildren.org to accept contributions. Volunteers are needed in all areas but especially on the Literature and Member Services Committees. The Preamble workgroup meets every Monday at 8pm EST on Zoom. Contact Tamara to get the contact information or join SLACK or go to the ACAWSO.org website. The WSO Office has reopened after 4 days of closure due to COVID-
19. Jean will ask Tamara to submit her written report to the gmail to be posted on the website.

## IGR (Intergroup Representatives) reports:

- Monday 9:30am "ACA Scotts Valley" meeting: Jeannie reported the meeting is held on Zoom with average attendance between 15-20 and Jeannie will bring up the $7^{\text {th }}$ Tradition in the chat box at the meeting.
- Monday 11:00am "Quiet Fellowship" meeting: They have transitioned to a telephone meeting with very low attendance. The meeting can use support.
- Monday 5:30pm "Stepping up in ACA": Good attendance of 20-25, a solid meeting. The meeting is held on Zoom.
- Monday 7:30pm: Meeting on Zoom with 9-12 attending and they are collecting the $7^{\text {th }}$ Tradition on PayPal. Sweet meeting. Zoom information to not be posted on website by group conscience.

- Outreach - Jeannie reported no meeting was held on April $13^{\text {th }}$ due to COVID-19. The committee needs volunteers. Ursula will be contacting Jeannie to transfer data analysis and visualization she performed on meeting attendance. Jeannie asked meetings to continue to keep attendance records including newcomers. In monthly IGR report, attendance can be reported.
- Boundaries Workshop - There will not be one in May, perhaps one will be held in June. Timing will be reviewed.

- Retreat 2021 Committee - Evie reported the venue has been chosen as Koinonia in Corralitos. The committee is working on a logo for the theme: No Shame, No Blame. The number of participants will be a minimum of 25 , and a maximum of 30 , with 10 on a waitlist and 30 commuters. Dates for the Retreat were originally thought to be January or February 2021, but the committee is now researching a March 2021 date. A \$500 deposit will be needed for 25 , and a $\$ 600$ deposit for 30 attendees. If social distancing is still in effect, the Retreat will probably not take place. The committee will continue to plan the Retreat, expecting the best.
