 - We will receive payment only by Venmo, cash or check; revise registration and RSVP to state Venmo is preferred

 - "What might I bring" section will be revised to also include 7th Tradition cash
 - Cut off registration on 9/25 to have head count and dietary needs (10 days in advance of the event)

- 2. There is plenty of parking! I'll include a parking map for you to look over. There will be cars from the other group on site, but there is typically enough parking.

- 6. Okay, thanks for letting me know. We will light the fire around 4:25-4:30.
- 7. Once you have all your dietary restrictions in, let me know and we will get those numbers to the kitchen.
- 8. You are more than welcome to use the campfire amphitheater for your improv class! We have a stage and

sound system down there which you can use if you want.

- 9. If you'd like to include this in your letter, these are the site rules we usually give to overnight guest groups:
- -All areas of camp are non-smoking, except basketball court
- -No alcohol, wine, beer, or drugs allowed on campgrounds
- -No pets allowed on campgrounds
- All children must remain under parent or guardian supervision
